Town Administrator Fred Blanco stated that there must be 2 public hearings, he is proposing Tuesday, February 11, 2025, at 6:00 PM, and Tuesday, February 18, 2025, at 6:00 PM. The notice will be posted in the San Benito News. Motion was made by Alderman Vera, seconded by Alderman Ricoy, and unanimously carried, to approve Resolution No. 403 – A RESOLUTION SETTING A DATE, TIME, AND PLACE FOR PUBLIC HEARINGS ON THE PROPOSED ANNEXATION OF CERTAIN PROPERTY BY THE TOWN OF RANCHO VIEJO, TEXAS, AND AUTHORIZING AND DIRECTING THE MAYOR TO PUBLISH NOTICE OF SUCH PUBLIC HEARINGS, PROVIDE WRITTEN NOTICE, AND OTHERWISE COMMENCE THE ANNEXATION PROCESS, setting the public hearings on Tuesday, February 11, 2025, at 6:00 PM, and Tuesday, February 18, 2025 at 6:00 PM.

7. COMPREHENSIVE PLAN UPDATE - DANIELLE ROJAS, GRANTWORKS:

Danielle Rojas for GrantWorks gave a brief update on the Comprehensive Plan. She stated that after the Open House that she held on October 24th at Town Hall, the key comment from residents was their concern about the land on the abandoned golf course. This is not part of the comprehensive plan, and the golf course is privately owned. Ms. Rojas asked the Board if they wanted to pause the comprehensive plan and address the issue, she would be able to further study and make recommendations after a complete analysis. The Board stated they will be holding a public workshop on Tuesday, January 21, 2025, at 6:00 PM at the Town Hall. There will be a brief presentation of the current study and our goals, and we can receive input from the public.

8. CONSIDERATION/ACTION ON APPROVAL OF PROPOSAL FOR PROFESSIONAL ENGINEERING SERVICES FOR THE STREET REPAIRS OUTLINED IN ROAD ASSESSMENT DATED NOVEMBER 2024 IN TABLE 3 THROUGH 5 AND DRAINAGE IMPROVEMENTS ON THE BEND AND SANTA ANA AVENUE:

Town Engineer Jose Munoz from Guzman and Munoz Engineering stated that the proposals for the street repairs on the Road Assessment dated November 2024 were on table 3 through 5 and included drainage improvements on Resaca Bend and Plantation Drive and on Santa Ana Avenue. He mentioned the tasks. Mr. Vera asked about the items in the assessment, and he mentioned the tasks should be corrected to be through table 6 to include the seal maintenance program. If there were further amendments, they would be adjusted, and they would initiate a Street Committee meeting.

Motion was made by Alderman Vera, seconded by Alderwoman Burnias, and unanimously carried, to approve the proposal for Professional Engineering Services for the Street Repairs Outlined In ROAD ASSESSMENT DATED NOVEMBER 2024 with the correction to be in table 3 through 6 and drainage improvements on The Bend and Santa Ana Avenue projects.

9. CONSIDERATION/ACTION OF CONTRACT WITH BUILDING INSPECTOR:

Motion was made by Alderman Ricoy, seconded by Alderwoman Burnias, and unanimously carried, to appoint Moises Navarro as Building Inspector for a 1-year term. There are no changes to the existing fee schedule.


